➤ It's a process through the ATR policy that allows a First Nation to expand their Reserve Land Base

➤ It's an instrument Indigenous Services Canada (ISC) utilizes to implement the ATR process

Mathini-kan Anishinaabek oda-ya-na-wa Oma ogii Canada chi-aba gii-towat Oshi-to-wat ishko-ni-gan

What authority grants an ATR?

The Indian Act does not deal with ATR's

Anishinaabe on-nagonikwin onda si-ganth-awa ATR's.

1. ATR's are granted by ROYAL PEROGATIVE exercised by the Governor General in General in Council through an Order in Council

ATR's oma ogii-menawak oma ohgii kan-iganagith-o-wat okimak oma ongi onakoni-kay-wii nik

- ROYAL PREROGATIVE means the power of the Crown, as represented by the Governor in Council, to take action as an exercise of the executive power. Setting as side Land as Reserve is on such power
- Gii gi-okima win-ata mask-co withi-win ayat oma gii-ni-ganish-kag oway on-koni-kay-win. Pa-kan aki agiii-kadic isoni-kan gii-ta-na-padak mi-way mas-cow-withi-win.

2. Another authority derives from the Claims Settlement Implementation Acts. There is an Act for Alberta, Saskatchewan and Manitoba.

Minawa pesik kan-ikanagii-thoth wapa-da-way-wak onnasow-way-win kawi-ishi chi-kakig. On-nashoway-win kawi-ishgish-kak aya-ma-katon Alberta, Saskatchewan tago Manitoba.

- This authority is only applicable to FN's that have opted in
- Anishinaabek ata awi-giid-mowad oway ishi-chika-win ta mina-wak.
- Under this act, land is set apart as Reserve by Ministerial Order. It provides for a pre-reserve designation process and other tools that can accelerate an ATR and provide for greater certainty to third party interests.
- Miway ishi-chi kawin Aki pakan achi-kata, iskoigan a-way ki-chi-ogimak ontinago-ni-kay-win.

THERE ARE 3 ATR POLICY CATEGORIES

Niswi aya-maka-toon ona-koni-gay-winan

An ATR initiative must clearly fit into one of these categories.

Piko ATR giimino thay-ik oma ish bezhig ona-koni-kay-win-nik

1. **Legal Obligations and Agreements:** To fulfill a legal obligation, for instance, a settlement agreement, a land claims settlement

Ohna-so-ay-win Chi-pi-min-isa-mowat onago-ni-gay-winan Ka-chi-nako gi-onkonga-wat Aki Ka-wakonat-mink

2. **Community Additions:** where a First Nation needs more land because of community growth, for protection of cultural sites and for economic development

Anishinaabek a-washi-may Aki kadaway da-mo-wat ohtham anini-patanin-owat anoki-wi-nan gii-osit-ito-wat

3. **Tribunal Decisions:** Where a First nation wants to acquire with funds awarded by a Specific Claims Tribunal

Oni-kan-niik ka onako-nika-wat Anishinaabek chi-who-dithiwat sooniyan ogi oni-shi-way-wi-ning

.... While ATR's may be time consuming, the new land transferred to Reserve Status is a fulfillment of outstanding land as promised by the Crown, for community growth, protection of cultural sites or economic development, depending on the location.

Gi mana-gii ka tig Anishinaabek Ka-tanakamigitiwat isko anoki-winan Ka-oshi-gi katakin.

ATR is about expanding the Reserve land Base ATR oway ogi chi-micha-gi gat-ak isonikan.

Once ATR has been triggered, a proposal must be developed *Ki-kishi-chi gatak ATR mazina-igan chi-oshi gi-kat.*

ATR / RC Proposal Criteria Introduction

The First Nation, in developing an ATR / RC proposal must consider a set of criteria designed to ensure that the needs and rights of all who may affected by the ATR are taken into full consideration. In addition, the First nation must show that there are benefits on both the social and economic levels.

Anishinaabek oshi-ito-wat masina-igan ka-chi-nako giita-goko nido kawinawa oko-gana-wa-pa miko-wat way ATR.

The criteria is as follows

- 1. Duty to consult *Gii-wi-chiwat awiya*
- 2. Environmental Management Kishi-by Ka-na-ka-chi chi-kat-ak Aki
- 3. Improvements to Proposed Reserve Lands Kata-shi-kigat kakw-way-daik iskonigan Aki
- 4. Other Federal Governmental Departments / Agencies Ogimakan tago anokiwinan-awat
- 5. Existing Encumbrances

- 6. Third Party Access

- 7. Land Description

- 9. Local Governments *Ogimaawining odanokii*
